## TRAILER RENTAL AGREEMENT TERMS AND CONDITIONS

1. TRAILER TO BE RETURNED IN THE SAME CONDITION AS WHEN PICKED UP (EXCEPT FOR ORDINARY WEAR AND TEAR)
2. TRAILER IS TO BE RENTED OR OVERLOADED ACCORDING TO THE ACTS (APPROPRIATE TRAILER MARK STAMPED ON THE COMPLIANCE PLATE)
3. ONWARD TRAILERS NOT TO BE TAKEN OFF ROAD. EG. ROADS NOT SEALED WITH A HARD MATERIAL SUCH AS TAD OR BITUMEN, UNLESS PRE AUTHORIZED BY PROMOTOR TRAILERS.
4. ANY DAMAGE TO THE TRAILER OR A THIRD PARTY DUE TO MIS USE, MIS JUDGEMENT, UN SECURED TRAILER AND OVERLOADS WILL BE AT RISKER EXPENSE.
5. FOR ANY EXTENSION TO THE TRAILER HIRE AGREEMENT, THE RISKER MUST INFORM PROMOTOR TRAILERS FOR AUTHORIZATION BEFORE ONWARD, RETURN DATE.
6. YOU AUTHORISE PROMOTOR TRAILERS TO DEBIT YOUR CREDIT CARD FOR:
  - \* ANY EXTENSION OF HIRE AT HALF OR FULL DAY RATE
  - \* ANY UNUSUAL REPAIR COSTS TO THE TRAILER OTHER THAN FROM ORDINARY WEAR
  - \* ANY ROAD SIDE ASSISTANCE OR RECOVERY COSTS OTHER THAN THE DRAIN AND PULLER FOR HIRE.
  - \* EXCESS PAYMENT FOR LOSS OR THEFT OF TRAILER WHILE HIRER TO YOU.
7. \* I HAVE READ AND UNDERSTOOD THE TERMS AND CONDITIONS OF PROMOTOR TRAILERS RENTAL AGREEMENT ON THE REVERSE OF THE PAGE AND HAVE SIGNED IT BEFORE MAKING AN AGREEMENT TO HIRE A TRAILER.
